Needs Statement: Mirage needs to continue incorporate more systems to evaluates all content areas with the support of specialists and collaborative teams.

Desired Outcomes: Due to effects of COVID 19 and Virtual Learning for some kids during the 21-22 school year and student/staff absences, Mirage has struggled with keeping up with the Tier 1 core curriculum, pacing guides and expectations of curriculum maps. With the input and guidance of staff members, we need to continue to create an effective PLC system that monitors, reviews, and evaluates all content areas(Math, ELA, Sci/SS, SEL) to ensure alignment of standards, resources, curriculum, and assessment.
